It is the central data hub that collects and enriches securities identification data from global National Numbering Agencies (NNAs) making it available to other ANNA members, authorities and financial market participants.

The ASB provides **single-point access** to standardised financial and referential instrument identifier data that helps organisations to meet their regulatory requirements and assist authorities with their supervisory functions.

On a daily basis, the ASB receives and consolidates new and updated ISIN, FISN and CFI data from members across the globe.
